AND WHEREAS, the student who had applied for admission for the said course in Bhavnagar Medical College (hereinafter referred to as "the said college.)NOW the condition of above written obligation is that if the student shall:

- (1) Fail to complete the M.B.B.S. (Bachelor of Medicine and Bachelor of Surgery) course as here in above provided that candidate shall pay to the Government on demand the amount of penalty of Bond as prescribed here under.
