"The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (10/02/2017) along with the Council Assessor's Report (April, 2016) and compliance dated 13/10/2016 submitted by the college authorities and decided to recommend to the Central Government that MD(Psychiatry) qualification against increased intake from 02 to 03 seats granted by Maharaja Krishnakumarsinghji Bhavnagar University, Bhavnagar in respect of students being trained at Government Medical College, Bhavnagar be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition.
