"The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (27/03/2015) along with the Council Assessor's Report (April, 2014) and compliance shield 07/10/2014 submitted by the College Authorities and decided to recommend to the Central Government that MD(General Medicine) qualification against increased intake from 04 to 05 seats gravited by Alabaraga Erishnakumarsinghji Bhavnagar University, Bhavnagar in respect of students Seing trained at Government Medical College, Bhavnagar be recognized and included in the 1st Schedule to the LMX_Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the fustitute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
