The Council approved the following recommendations of the Postgraduate Committee, which I am directed to convey herewith for your information and necessary action:

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (April, 2015) and decided to recommend to the Central Government that MD(Pharmacology) qualification against increased intake from 03 to 04 seats grained by Maharaja Krishnakumarsinghii Bhavinggar Elmorisity, Bhavinggar in respect of students being trained at Government Medical College, Bhavinggar be recognized and included in the 1st Schedule to the LM.C. Act, 1956.

The Postgraduale Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall inemiably result in stoppage of admission to the Postgraduate Course."
